## SJRCS H.S.A. Auction PROXY BID FORM

### Terms and Conditions

1. I am over 18 years of age, and can form legally binding contract under applicable law.
2. By signing and submitting this form, I authorize an SJRCS Auction Representative to place bids on my behalf for the above item(s) **up to and including** the amount maximum bid amount.
3. I understand that this representative will place bids at the increments set by the auctioneer at the live auction, or the pre-determined increments at the silent auction.
4. If my proxy bid is the highest made at the "Have We Got a Fair For You" Auction event on 6/1/08, I will win the bidding, and **I authorize my credit card above to be charged in that amount.** If I wish to make payment in cash or check instead, I will notify the auction representative when informed of my winning bid.
5. I understand that I will receive an email confirmation of my winning bid to the email address submitted, no later than June 5, 2008.
6. I understand that my winning item will be mailed to me by regular US Postal Service (USPS) or United Postal Service (UPS) at the above billing address within 7-10 days (not including delivery time) after the auction, unless I have made arrangements for me or my representative to pick up the item at a mutually agreed upon location and date. If my shipping address is different from my billing address, I will notify an SJRCS Auction Representative when I am informed of my winning bid. I understand that I will be charged for all shipping fees.
7. I understand that in the event that two proxy bids tie for the same item, the proxy bidder who submitted their proxy bid form first will win the item.
8. I understand that any Proxy Bid Form containing any qualifying statements attached to any items will not be accepted. For example, you may not state: "Subject to my approval", "If there is not scheduling conflict", or "If the performance/reservation is on a weekend."
9. I understand that the SJRCS H.S.A. "Have We Got a Fair For You" Auction Committee reserves the right to refuse to accept any proxy bid for any reason, including but not limited to proxy bids that are lower than the minimum starting bids for an items.
10. I understand that my submission of the Proxy Bid Form is **final**. I understand that I may not alter this proxy bid that I have submitted for proxy bidding in any way, including the authorized maximum bid amount. It is recommended that I make a personal copy of this entire, completed form, prior to submission.
